  - a. Review Shared Plan– Greg Parker**

2023-2025 Shared Plan Completed – Service Coordination Mechanism Updated, Added Staff Knowledge in OASCIS, Members in Committee's - Health Alliance, Prevention Coalition, and Community Council.  
Will be working on the 2026-2028 Shared Plan soon that's due in August. Will be adding Review of the By Laws, reassessing some funding projects and ways to add In-Home Therapy and respite care.
  - b. Wyandot County Early Intervention Corrective Action Plan – Greg Parker**

The FCFC is still under the EI CAP until June 30, 2025, though the CAP is on hold as we transition the program. The FCFC will be transitioning the program to the Health Department completely by July 1, 2025. The CAP will not continue once the program has moved departments. The EI program has started receiving referrals from local doctors thanks to work being done by April and the team since they've started.
- 5. New Business –**
  - a. CY 2025 Appropriation Approval – Attachment 2025-0108-1 – Vanessa Krizek**

Adjustments include Hospitalization calculation adjustments, Friday Fun Fest Pool Invoice, Client Services for KFT Respite & SF/SC Budget and Increase to 8004 Salaries and Fringes to increase grant spending.

**b. SFY25 4SOSW Grant & Contract Approval for \$20,000 with Mental Health & Recovery Services Board of SOSW – Greg Parker**

Continuation of SFY24, which is a four-county grant for mental and behavioral health assessments for children in the county. Depending on the risk level we may be conducting a NOMS assessment, so that we can track the individuals' progress through the service coordination process.

The MHRSB has changed the grant process to submit for 2 years at a time. The services will likely be the same as SFY25 for both years for prevention services such as gambling, primary prevention, and parenting classes.

**a. Wraparound, Prevention and Mentoring Reports – Justin Swartz**

Wraparound currently has 10 families.

Ram squad has 45-60 kids showing up. We are trying to set it up every week instead of every other week, however, we still need volunteers for Wednesday's.

Thank you to everyone that worked on the focus groups for Epiphany. Your help is much appreciated.

**b. Early Intervention Report – Greg Parker**

April Gottfried – EI has 13 kids, with 6 new referrals from Help Me Grow Home Visiting (HMG HV), local doctor, parents. I have personally evaluated 4 kids so far. Learning how to perform an IEP next week. Learned that once annual reviews are completed by Seneca County, the kids will come back to Wyandot County to continue the case.

**1. EI Mid-Year report – Greg Parker**

The reporting period is July 1, 2024 through December 31, 2024:

EI received 37 referrals, most of which came from parents and PCSA, the remaining came from various agencies, hospitals and physicians.

Eligibility – Number of children referred – 18; Children determined eligible for EI – 10; Number of evaluations completed – 11; Number for new referrals with a completed IFSP – 7.

During this timeframe, FCFC had a part-time contract manager and between July-August had a part-time EI service coordinator.

EI coordination services were contracted out to Seneca County in November 2024 for a short term to help the Health Department transition to take over evaluations.

Services provided by the Wyandot County Board of DD include Occupational therapy, Physical therapy and Speech therapy. We have contracted with Westcon and Clearwater COG's to provide evaluations assessments.

Compliance – 45-day timeline is 75%; Notification of LEA & SEA is 100%.

**c. FCFC Report – Greg Parker**

We applied for and received approval for Shared Plan Incentive Funding for around \$16,000. There are some key things that need to be addressed in the Shared Plan because of the funding that the committee can work on. Some key factors that can be focused on include addressing: Substance use prevention programming, Infant vitality, trauma informed care, family and youth voice, services and support for multi-system youth.

**7. Community Reports**

**a. Mental Health and Recovery Services Board – Rose Robbins**

The board received a bipartisan grant to create a comprehensive mental health preparedness plan. The current award is \$48,848.42. Will be working with First Responders and other community partners to prepare the plan. The final Behavioral Health Disaster Preparedness Plan will be on the MHRSB website by the end of the grant year which is September 29, 2025.

**b. Job & Family Services – Jason Fagan**

Busy season is coming up for our Comprehensive Case Management and Employment Program (CCMEP) will be 14–21-year-old recruiting for employment.

22 counties have a rep in office for unemployment – Wyandot County's office day is Thursday. There has been an increase in unemployment claims.

Watching federal funding in DC to see if there will be any changes affecting JFS. Gov. DeWine's preliminary budget is showing an increase in funding.

Megan Rowe – Foster Care Treatment Collaborative with Wyandot, Seneca, Sandusky, Ottawa, Hancock, Huron and Wood county's goal is find and license treatment foster care homes in our areas. The Northwest Ohio Fellowship Program recruits' students for paid internships. Hope is to boost the workforce, especially within children's services, where turnover is high. It gives students an opportunity to work within a field they may not know they would have an interest and gain valuable skills while in school.

c. **Health Department – Kelli Owens**

Also currently watching the federal funding closely

Candice Kimmel – Have 3 harm reduction vending machines around the county stocked with Covid tests, Narcan, Deterra bags, and safe sex kits. Looking into a way to provide poverty period kits as well.

Walk-in Wednesday clinic for Flu & Covid shots

Community Youth Tobacco Group to prevent the use of tobacco in youth.

Krystina Auble – WIC caseload is currently 377.

d. **Preschool Head Start – Amiee Nye**

Re-enrollment started for current students and will begin outside enrollment soon.

e. **Other Community Reports**

Parent & Youth Ambassador – Marcy Jett – Have a Play group/Prent Support group for Parents and children aged 0-3 years olds held in Lima.

Open Door Resources – Scott Moore – 211 is now available in Wyandot County for any service needs and will connect to a live operator 24/7. United Way is the resource for the 211 networks if you want your agency included within the 211 resources.

WyandotHelps.org magnets, trifolds and window clings are available at the Health Department.

Harbor – Stephanie Gordon – Ohio Rise received 4 new referrals in January and February – 1 in-patient and 3 from CPS. Currently serving 14 children under Tier 2 care coordination.

Parent peer support is currently at capacity in Wyandot County. We will continue to take referrals, and as cases are completed spots will be filled.

Charlie Health – Hadley Weimer – Have an Intensive Child Health program. Recently, I have received referrals from Wyandot Hospital lately.

Board of DD – Todd Dilley – March is DD Awareness month; this year's theme is "Superhero's - Ordinary People with Extraordinary Abilities"

Parent Rep – Norma Williams – Trinity is preparing for the Special Needs Prom "Celebration of Miracles" that will be held on May 9
