Legal Description For Joel Walton 1.393 Acres

Situated in the Township of Eden, County of ~~Crawford~~, State of Ohio and being part of the Southwest Quarter of Section 13, Township 2 South, Range 14 East and more particularly described as follows:

Commencing at a 1 inch iron pipe found marking the southeast corner of said Southwest Quarter, which point is also located on the centerline of County Highway 47; thence on an assumed bearing South 83 degrees 56 minutes 48 seconds West a distance of 360.33 feet along the south line of said Southwest Quarter and centerline of County Highway 47 to a PK nail found; thence North 05 degrees 22 minutes 00 seconds West a distance of 1,162.85 feet to a 5/8 inch iron pin set marking the northwest corner of a 0.87 acre tract recorded in Deed Book 175, Page 70 and being the place of beginning; thence continuing North 05 degrees 22 minutes 00 seconds West a distance of 96.89 feet to a 5/8 inch iron pin set; thence South 84 degrees 38 minutes 00 seconds West a distance of 16.34 feet to a 5/8 inch iron pin set; thence North 05 degrees 22 minutes 00 seconds West a distance of 107.56 feet to a 5/8 inch iron pin set; thence North 84 degrees 38 minutes 00 seconds East a distance of 291.34 feet to a 5/8 inch iron pin set, passing over a 5/8 inch iron pin set at 182.69 feet; thence South 05 degrees 22 minutes 00 seconds East a distance of 351.86 feet to a 5/8 inch iron pin set, passing over a 5/8 inch iron pin set at 128.91 feet; thence South 84 degrees 38 minutes 00 seconds West a distance of 15.00 feet to a 5/8 inch iron pin set marking the southeast corner of said 0.87 acre tract; thence North 05 degrees 22 minutes 00 seconds West a distance of 137.41 feet along the east line of said 0.87 acre tract to a 5/8 inch iron pin set; thence South 84 degrees 38 minutes 00 seconds West a distance of 50.00 feet along the northerly line of said 0.87 acre tract to a 5/8 inch iron pin set; thence North 05 degrees 22 minutes 00 seconds West a distance of 10.00 feet along an easterly line of said 0.87 acre tract to a 5/8 inch iron pin set; thence South 84 degrees 38 minutes 00 seconds West a distance of 210.00 feet along the north line of said 0.87 acre tract to a 5/8 inch iron pin set and being the place of beginning.

The above described tract of land contains 1.393 acres, more or less, based on a survey by Robert Lyn Makeever, P.E., P.S., Professional Surveyor Number 6828, dated November 2, 1988 but is subject to all highways, easements and restrictions of record.
