Being a parcel of land situated in part of the Southeast Quarter of Section 13, T-1-S,
R-13-E, Crawford Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found railroad spike marking the intersection of Township Highway 18
and the west line of the east half of the southeast quarter of said Section 13 and being the
POINT OF BEGINNING;

thence on an assumed bearing of N 90° 00' 00" E along said centerline a distance of
220.00 feet to a point;

thence S 01° 14' 25" E a distance of 504.64 feet to an iron pipe, passing an iron pipe a
distance of 12.37 feet;

thence S 90° 00' 00" W a distance of 220.00 feet to an iron pipe;

thence N 01° 14' 25" W a distance of 504.64 feet to the **POINT OF BEGINNING**,
passing an iron pipe a distance of 304.64 feet.

Containing in all 2.548 acres of land, more or less, being subject to all legal highways
and easements of record.

Bearings are assumed and are for angular measurement only.
