thence S 00° 33' 46" E seventy-one and one hundredth (71.01) feet along the westerly right-of-way of South Hazel Street to a set iron rod;

thence S 89° 59' 50" W one hundred seventeen and thirty hundredths (117.30) feet to a set iron rod on the westerly line of said Lot 106;

thence N 00° 33' 46" W seventy-one and one hundredth (71.01) feet to a set iron rod on the southerly right-of-way of Spring Street;

thence N 90° 00' 00" E one hundred seventeen and thirty hundredths (117.30) feet along the southerly right-of-way of Spring Street to THE POINT OF BEGINNING.

Containing in all, 0.191 acres of land, more or less, subject to all legal highways and easements.
