**LEGAL DESCRIPTION OF A 3.613 ACRE PARCEL
FOR PAUL D. WALTER**

Being a parcel of land situated in part of the Northwest Quarter of Section 33, T-2-S, R-12-E, Richland Township, Wyandot County, Ohio, and further described as follows:

Commencing at an iron pipe marking the intersection of County Highway 79 and the east-west half section line of said Section 33;

thence on an assumed bearing of N 00° 26' 08" W along said centerline a distance of 1250.26 feet to a point marking the northeast corner of Tract #4 as shown on Survey Number 3145, as recorded in Survey Volume 7, Page 12 in the Wyandot County Tax Map Office and being the **POINT OF BEGINNING**;

thence S 88° 48' 22" W along the north line of said Tract #4 a distance of 175 feet to an iron pipe marking the northwest corner of said Tract #4, passing an iron pipe a distance of 20 feet;

thence S 00° 26' 08" E along the west line of said Tract #4 a distance of 249.04 feet to an iron pipe on the north line of Tract #3 as shown on said Survey Number 3145, marking the southwest corner of said Tract #4;

thence S 88° 48' 22" W along the north line of said Tract #3 a distance of 33.00 feet to an iron pipe marking the northwest corner of said Tract #3 and a northeasterly corner of Tract #5 of said Survey Number 3145;

thence S 89° 18' 19" W along the north line of said Tract #5 a distance of 402.23 feet to an iron pipe on a fence line marking the easterly right-of-way line of a railroad property;

thence N 34° 28' 43" E along said fence line/right-of-way line a distance of 242.13 feet to a 5 inch square concrete post marking a corner of said railroad property;

thence S 56° 59' 54" E along said fence line/right-of-way line a distance of 22.6 feet to a 5 inch square concrete post marking a corner of said railroad property;

thence N 36° 53' 38" E a distance of 436.59 feet to an iron pipe marking the westerly corner of Tract #1 of said Survey Number 3145;

thence S 54° 43' 39" E along the southerly line of said Tract #1 a distance of 282.73 feet to a point on the centerline of County Highway 79 marking the southerly corner of said Tract #1, passing an iron pipe a distance of 246.73 feet;

thence S 36° 05' 33" W along said centerline a distance of 69.82 feet to a railroad spike;

thence S 00° 26' 08" E along said centerline a distance of 58.53 feet to the **POINT OF BEGINNING**.

Containing in all 3.613 acres of land, more or less, being subject to all legal highways and easements of record.

Bearings are assumed and are for angular measurement only.
