SITUATED IN THE STATE OF OHIO, COUNTY OF WYANDOT, TOWNSHIP OF CRAWFORD AND BEING PART OF THE NORTHWEST QUARTER OF SECTION 35 TOWNSHIP 1 SOUTH, RANGE 13 EAST AND BEING

COUNTY ROAD NUMBER 29 FOR A DISTANCE OF 1576.87 FEET TO A NAIL SET

THENCE SOUTH 15 DEGREES 25 MINUTES 16 SECONDS EAST ON SAID LINE AND THE SOUTHEASTERLY EXTENSION OF SAID LINE FOR A DISTANCE OF 318.81 FEET TO A

PERSONALIZED PIPE SET, THE PLACE OF BEGINNING

THENCE SOUTH 15 DEGREES 25 MINUTES 16 SECONDS EAST ON THE SOUTHEASTERLY EXTENSION OF

SAID LINE FOR A DISTANCE OF 96.055 FEET TO A POINT ON A CURVE TO THE RIGHT OF THE CENTERLINE OF STATE ROAD NUMBER 199 WHICH HAS A RADIUS OF 4,092.56 FEET,

A CHORD BEARING OF SOUTH 27 DEGREES 00 MINUTES 20 SECONDS EAST AND A CHORD LENGTH OF 367.7778 FEET, THENCE ALONG THE CURVE OF SAID CENTERLINE FOR A DISTANCE OF

367.9017 FEET TO A POINT AT THE END OF SAID CURVE (SEE PLAT FOR REFERENCES)
