LEGAL DESCRIPTION

Being a parcel of land situated in the northeast quarter of Section 29, Salem Township, Town-2-South, Range-13-East, Wyandot County, Ohio described as follows:

Commencing at a found monument box marking the northeast corner of said section and the centerline intersection of County Highway 97 and Township Highway 49; thence S 90° 00' 00" W one thousand three hundred ten and twenty-three hundredths (1310.23) feet along the northerly line of said section and the centerline of Township Highway 49 to a set railroad spike, **THE POINT OF BEGINNING**;

thence S 00° 05' 00" W seven hundred four and one hundredths (704.01) feet to the centerline of a ditch, passing at twenty and zero hundredths (20.00) feet a set iron rod on line for reference and passing at six hundred eighty-seven and one hundredths (687.01) feet a set iron rod on line for reference;

thence following the meandering centerline of said ditch:

thence S 76° 53' 21" W thirty-eight and ninety-two hundredths (38.92) feet from which a set iron rod for reference bears N 00° 00' 00" E thirty-one and zero tenths (31.0) feet;

thence N 38° 24' 04" W forty-three and forty hundredths (43.40) feet from which a set iron rod for reference bears S 83° 37' 10" E twenty-seven and one tenths (27.1) feet;

thence N 60° 04' 26" W one hundred thirty-five and fifty-five hundredths (135.55) feet from which a set iron rod for reference bears N 00° 00' 00" E twenty and zero tenths (20.0) feet;

thence N 77° 49' 24" W two hundred two and ninety-seven hundredths (202.97) feet;

thence N 00° 30' 00" W five hundred sixty-eight and forty-one hundredths (568.41) feet to set railroad spike on the northerly line of said section and the centerline of Township Highway 49, passing at twenty and zero tenths (20.0) feet a set iron rod on line for reference and passing at five hundred forty-eight and forty-one hundredths (548.41) feet a set iron rod on line for reference;

thence N 90° 00' 00" E three hundred eighty-six and seventy-three hundredths (386.73) feet along the northerly line of said section and the centerline of Township Highway 49 to **THE POINT OF BEGINNING**.
