SITUATED IN THE STATE OF OHIO, COUNTY OF WYANDOT, TOWNSHIP OF CRAWFORD AND BEING PART OF THE NORTHEAST QUARTER OF SECTION 27 TOWNSHIP 1 SOUTH, RANGE 13 EAST AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS: COMMENCING AT A NAIL SET AT THE INTERSECTION OF THE NORTH LINE OF SECTION 27 WITH THE CENTERLINE OF STATE ROAD NUMBER 199 THENCE ON AN ASSUMED BEARING OF SOUTH 0 DEGREES 49 MINUTES 00 SECONDS EAST ALONG THE CENTERLINE OF STATE ROAD NUMBER 199 FOR A DISTANCE OF 864.48 FEET TO A NAIL SET AT THE POINT OF CURVATURE OF SAID CENTERLINE. THENCE ON A CURVE TO THE LEFT OF 4297.18 FEET RADIUS (THE CHORD BEARING BEING SOUTH 1 DEGREE 43 MINUTES 46 SECONDS EAST AND THE CHORD LENGTH BEING 136.92 FEET) FOR A DISTANCE OF 136.926 FEET TO A POINT, THE PLACE OF BEGINNING THENCE CONTINUING ON A CURVE TO THE LEFT OF SAID LINE AND OF 4297.18 FEET RADIUS (THE CHORD BEARING BEING SOUTH 4 DEGREES 46 MINUTES 42 SECONDS EAST AND THE CHORD LENGTH BEING 320.326 FEET) FOR A DISTANCE OF 320.40 FEET TO A POINT ON THE C.E. TOLAND, ETUX. NORTH LINE.

THENCE SOUTH 89 DEGREES 55 MINUTES 06 SECONDS WEST ON SAID LINE FOR A DISTANCE OF 50.724 FEET TO A PERSONALIZED PIPE SET AS A REFERENCE

THENCE SOUTH 89 DEGREES 55 MINUTES 06 SECONDS WEST ON SAID LINE FOR A DISTANCE OF 147.37 FEET TO A PERSONALIZED PIPE SET.

THENCE NORTH 0 DEGREES 18 MINUTES 07 SECONDS WEST ON A LINE FOR A DISTANCE OF 284.11 FEET TO A PERSONALIZED PIPE SET.

THENCE NORTH 78 DEGREES 25 MINUTES 58 SECONDS EAST ON A LINE FOR A DISTANCE OF 126.08 FEET TO A PERSONALIZED PIPE SET AS A REFERENCE

THENCE NORTH 78 DEGREES 25 MINUTES 58 SECONDS EAST ON A LINE FOR A DISTANCE OF 50.42 FEET TO
