Commencing at a railroad spike set at the intersection of the North Line of Section 33 with the centerline of Township Road 97 (also being the West Line of Section 33); thence along said centerline S 0° 00' 00" E for a distance of 580.00 feet to a railroad spike set and the point of beginning; thence S 86° 20' 40" E for a distance of 625.00 feet to a 5/8" dia. iron pin set on Grantor's East line (passing over a 5/8" dia. iron pin set at 35.06 feet); thence along Grantor's East line S 0° 27' 35" E for a distance of 502.12 feet to an existing railroad tie post on the Wyandot Reservation Line; thence along said Line N 87° 35' 45" W for a distance of 628.31 feet to a railroad spike set on the centerline of Township Road 97 (passing over a 5/8" dia. iron pin set at 598.28 feet); thence along said centerline N 0° 00' 00" W for a distance of 515.60 feet to a railroad spike set and the point of beginning.

Beginning at a railroad spike set at the intersection of the centerline of Township Road 97 (also being the West Line of Section 33) with the North Line of Section 33; thence along said North Line N 89° 48' 10" E for a distance of 618.75 feet to a 5/8" dia. iron pin set on Grantor's East line (passing over a 5/8" dia. iron pin set at 30.00 feet); thence along Grantor's East line S 0° 27' 35" E for a distance of 622.00 feet to a 5/8" dia. iron pin set; thence N 86° 20' 40" W for a distance of 625.00 feet to a railroad spike set on the centerline of Township Road 97 (passing over a 5/8" dia. iron pin set at 589.94 feet); thence along said centerline N 0° 00' 00" W for a distance of 580.00 feet to a railroad spike set on the North Line of Section 33 and the point of beginning.
