

LEGAL DESCRIPTION

REFERENCE DEED BOOK 132 PAGES 1 AND 2.

SITUATED IN THE STATE OF OHIO, COUNTY OF WYANDOT, TOWNSHIP OF SALEM AND BEING PART OF THE SOUTHWEST QUARTER OF SECTION 29 TOWNSHIP 2 SOUTH, RANGE 13 EAST AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS: BEGINNING AT A PERSONALIZED PIPE SET AT THE CENTER POST OF SAID SECTION, THENCE ON AN ASSUMED BEARING OF NORTH 89 DEGREES 51 MINUTES 22 SECONDS WEST ALONG THE EAST-WEST HALF SECTION LINE FOR A DISTANCE OF 912.18 FEET TO A PERSONALIZED PIPE SET AT THE INTERSECTION OF THE WYANDOT RESERVATION LINE WITH THE EAST-WEST HALF SECTION LINE

THENCE NORTH 89 DEGREES 45 MINUTES 44 SECONDS WEST ON THE EAST-WEST HALF SECTION LINE FOR A DISTANCE OF 412.50 FEET TO A PERSONALIZED PIPE SET ON THE M.R. BROADMAN EAST LINE

THENCE SOUTH 0 DEGREES 34 MINUTES 03 SECONDS WEST ON SAID LINE AND THE W.M. REBER, ET AL EAST LINE FOR A DISTANCE OF 2592.575 FEET TO A PERSONALIZED PIPE SET AS A REFERENCE

THENCE SOUTH 0 DEGREES 34 MINUTES 03 SECONDS WEST ON SAID LINE FOR A DISTANCE OF 44.42 FEET TO A POINT ON THE CENTERLINE OF STATE ROAD NUMBER 30 AND THE SOUTH LINE OF SAID SECTION. THENCE SOUTH 89 DEGREES 32 MINUTES 41 SECONDS EAST ON SAID LINE FOR A DISTANCE OF 412.50 FEET TO A REFERENCED POINT AT THE INTERSECTION OF THE WYANDOT RESERVATION LINE WITH THE CENTERLINE OF STATE ROAD NUMBER 30 AND THE SOUTH LINE OF SAID SECTION.

THENCE NORTH 89 DEGREES 30 MINUTES 19 SECONDS EAST ON THE CENTERLINE OF STATE ROAD NUMBER 30 AND THE SOUTH LINE OF SAID SECTION FOR A DISTANCE OF 117.09 FEET TO A REFERENCED POINT

THENCE NORTH 0 DEGREES 56 MINUTES 21 SECONDS EAST ON A LINE FOR A DISTANCE OF 30.864 FEET TO A PERSONALIZED PIPE SET AS A REFERENCE

THENCE NORTH 0 DEGREES 56 MINUTES 21 SECONDS EAST ON A LINE FOR A DISTANCE OF 794.64 FEET TO A PERSONALIZED PIPE SET.

THENCE NORTH 90 DEGREES 00 MINUTES 00 SECONDS EAST ON A LINE FOR A DISTANCE OF 807.11 FEET TO A PERSONALIZED PIPE SET ON THE NORTH-SOUTH HALF SECTION LINE

THENCE NORTH 0 DEGREES 01 MINUTES 06 SECONDS EAST ON SAID LINE FOR A DISTANCE OF 1809.73 FEET TO
