SITUATED IN THE STATE OF OHIO, COUNTY OF WYANDOT, VILLAGE OF CAREY AND BEING  
PART OF LANDS IN THE EAST PART OF THE WEST HALF OF THE SOUTHEAST QUARTER  
OF SECTION 17, TOWNSHIP 1 SOUTH, RANGE 13 EAST, BEING PART OF THE RIGHT-OF-  
WAY OF THE FORMER FINDLAY BRANCH OF THE C. C. C. AND ST. L. RAILROAD AND BEING  
MORE PARTICULARLY DESCRIBED AS FOLLOWS: COMMENCING AT AN IRON PIN FOUND  
AT THE SOUTHEAST CORNER OF LOT 1 OF D. STRAW'S FIRST ADDITION TO SAID VILLAGE,  
THENCE ON AN ASSUMED BEARING OF

SOUTH 02 DEGREES 15 MINUTES 00 SECONDS EAST ON THE WEST RIGHT-OF-WAY LINE OF  
OF WEST STREET FOR A DISTANCE OF 170.76 FEET TO A PERSONALIZED PIPE FOUND, THE  
PLACE OF BEGINNING

THENCE SOUTH 02 DEGREES 15 MINUTES 00 SECONDS EAST ON SAID LINE FOR A DISTANCE OF 8.67  
FEET TO A PERSONALIZED PIPE SET.

THENCE SOUTH 43 DEGREES 52 MINUTES 0 SECONDS WEST ON SAID LINE FOR A DISTANCE OF 51.735  
FEET TO A PERSONALIZED PIPE SET ON THE SOUTH LINE OF FORMER RAILROAD RIGHT-OF-WAY

THENCE ON A CURVE TO THE RIGHT OF 2064.83 FEET RADIUS OF SAID LINE FOR A DISTANCE OF 258.18  
FEET TO A 2 INCH  $\phi$  BRASS FOUND ON THE C. SNOOK NORTH LINE (THE CHORD BEARS SOUTH 83° 45' 12" WEST & IS 258.01 FEET LONG)

THENCE SOUTH 88 DEGREES 31 MINUTES 28 SECONDS WEST ON SAID LINE FOR A DISTANCE OF 53.213  
FEET TO 2"  $\phi$  BRASS FOUND ON G. KRAFT WEST LINE

THENCE NORTH 0 DEGREES 20 MINUTES 32 SECONDS WEST ON A LINE FOR A DISTANCE OF 27.646  
FEET TO A PERSONALIZED PIPE FOUND

THENCE NORTH 0 DEGREES 20 MINUTES 32 SECONDS WEST ON A LINE FOR A DISTANCE OF 23.09  
FEET TO A PERSONALIZED PIPE SET ON THE P.O.O.L.O.C. INC. SOUTH LINE & A CURVED R/W LINE

THENCE ON 5.11D CURVE TO THE LEFT OF 2005.83 FEET RADIUS --- FOR A DISTANCE OF 204.6639

FEET TO A PERSONALIZED PIPE SET (THE CHORD OF SAID CURVE BEARS NORTH 84° 48' 24" EAST AND IS 204.575 FEET LONG)  
THENCE NORTH 87 DEGREES 30 MINUTES 50 SECONDS EAST ON A LINE FOR A DISTANCE OF 141.89
