SITUATED IN THE STATE OF OHIO, COUNTY OF WYANDOT, TOWNSHIP OF EDEN AND BEING PART OF THE SOUTHEAST QUARTER OF SECTION 8 TOWNSHIP 2 SOUTH, RANGE 15 EAST AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS: COMMENCING AT A STONE AND MONUMENT BOX FOUND AT THE SOUTHEAST CORNER OF SAID SECTION, THENCE ON AN ASSUMED BEARING OF SOUTH 90 DEGREES 00 MINUTES 00 SECONDS WEST ALONG THE SOUTH SECTION LINE AND THE CENTER-LINE OF COUNTY ROAD NUMBER 44 FOR A DISTANCE OF 348.50 FEET TO A P.K. NAIL SET,

THENCE SOUTH 90 DEGREES 00 MINUTES 00 SECONDS WEST ON SAID LINE FOR A DISTANCE OF 532.185 FEET TO A P. K. NAIL FOUND ON THE R. J. BEILFUSS, ETUX. EAST LINE

THENCE NORTH 00 DEGREES 17 MINUTES 27 SECONDS WEST ON SAID LINE FOR A DISTANCE OF 26.055 FEET TO A PERSONALIZED PIPE FOUND AND USED AS A REFERENCE

THENCE NORTH 00 DEGREES 17 MINUTES 27 SECONDS WEST ON SAID LINE FOR A DISTANCE OF 387.95 FEET TO A PERSONALIZED PIPE FOUND.

THENCE SOUTH 78 DEGREES 51 MINUTES 04 SECONDS EAST ON A LINE FOR A DISTANCE OF 303.87 FEET TO A PERSONALIZED PIPE SET.

THENCE SOUTH 82 DEGREES 09 MINUTES 45 SECONDS EAST ON A LINE FOR A DISTANCE OF 235.38 FEET TO A PERSONALIZED PIPE SET ON THE G. JARRELL, ETUX. WEST LINE.

THENCE SOUTH 00 DEGREES 31 MINUTES 36 SECONDS EAST ON SAID LINE FOR A DISTANCE OF 296.68 FEET TO A PERSONALIZED PIPE SET AS A REFERENCE

THENCE SOUTH 00 DEGREES 31 MINUTES 36 SECONDS EAST ON SAID LINE FOR A DISTANCE OF 26.48 FEET TO
