thence N 00° 00' 00" E four hundred forty-eight and thirty-three hundredths (448.33) feet along said Gagnon's easterly line to a found iron rod;

thence N 89° 13' 50" W one thousand eight hundred thirty-six and fourteen hundredths (1836.14) feet along said Gagnon's northerly line to a set iron rod;

thence N 00° 00' 00" E one hundred fifty-four and fifty-four hundredths (154.54) feet to a set iron rod;

thence N 03° 23' 43" W three hundred eighty-six and fifteen hundredths (386.15) feet to a set iron rod on the southerly line of a parcel of land now or formerly by Irene Stover Gerstenberger as described in Deed Volume 132, page 282 in the Wyandot County Recorder's office;

thence S 89° 32' 05" E two thousand three hundred nineteen and thirty-three hundredths (2319.33) feet along said Gerstenberger's southerly line to a set iron rod marking the southeasterly corner thereof;

thence S 00° 07' 58" W nine hundred ninety-eight and twenty-one hundredths (998.21) feet along the north-south quarter section line of said Section 20 to THE POINT OF BEGINNING.

Containing in all, 33.582 acres of land, more or less, subject to all legal highways and easements.

thence N 00° 00' 00" E three hundred eighty-three and forty-two hundredths (383.42) feet along said centerline and said section line to a set P-K nail marking the southwesterly corner of a parcel of land now or formerly owned by Irene Stover Gerstenberger as described in Deed Volume 132, page 282 in the Wyandot County Recorder's office;

thence S 89° 32' 05" E three hundred thirty-five and seventy-five hundredths (335.75) feet along said Gerstenberger's southerly line to a set iron rod, passing at twenty and zero hundredths (20.00) feet a set iron rod on the easterly right-of-way of said rod;

thence S 03° 23' 43" E three hundred eighty-six and fifteen hundredths (386.15) feet to a set iron rod on an easterly extension of said Treadway's northerly line;

thence N 89° 14' 12" W three hundred fifty-eight and sixty-four hundredths (358.64) feet along said extension of Treadway's northerly line and said Treadway's northerly line to **THE POINT OF BEGINNING**.

thence S 89° 14' 12" E one hundred seventy-two and forty-four hundredths (172.44) feet to a set iron rod;

thence S 00° 00' 00" W one hundred fifty-four and fifty-four hundredths (154.54) feet to a set iron rod on the northerly line of a 10.138 acre parcel of land now or formerly owned by John Gagnon as described in Deed Volume 196, page 838 in the Wyandot County Recorder's office;

thence N 89° 13' 50" W one hundred seventy-two and fifty-one (172.51) feet along the northerly line of said Gagnon's parcel to a found iron rod on the easterly line of said Treadway's 0.250 acre parcel;
