LEGAL DESCRIPTION FOR A 1.001 ACRE PARCEL
FOR ARLEY R. MURPHY AND LISSIE M. MURPHY

Being a parcel of land situated in part of the NE $\frac{1}{4}$ of Section 14, Township 1 South, Range 12 East, Ridge Township, Wyandot County, Ohio described as follows:

Commencing at a found iron rod marking the intersection of the centerline of State Route 15 and County Road 21, relocated, said rod being at Station 1307 + 50.04 in the centerline of survey made in 1962 by the Ohio Department of Transportation of State Route 15, Section 0.00 in Wyandot County;

Thence S 68° 53' 10.4" E, 185.04 feet along the centerline of State Route 15 to Station 1305 + 65 of said centerline survey;

Thence N 21° 06' 49.6" E 150.00 feet to a set iron rod at the intersection of the right-of-ways of State Route 15 and County Road 21, relocated, said rod being 150.00 feet right of Station 1305 + 65 of said centerline survey;

Thence S 68° 23' 10.4" E, a distance of 414.75 feet to a found iron rod along the northerly right-of-way of State Route 15, the point of beginning;

Thence N 00° 40' 19.6" E, a distance of 244.65 feet to a found iron rod;

Thence N 17° 11' 42" E, a distance of 105.49 feet to a found iron rod on the southerly line of an easement as described in Deed Volume 134, Page 68 in the Wyandot County Recorder's Office; said easement being Parcel No. 320 B;

Thence N 00° 40' 19.6" E, a distance of 43.87 feet to a found PK nail on the centerline of County Highway 21;

Thence S 89° 19' 40.4" E, a distance of 82.92 feet to a set PK nail on the centerline of County Highway 21;

Thence S 00° 40' 19.6" W, a distance of 432.87 feet to a set iron rod on the northerly right-of-way of State Route 15, passing a set iron rod on the southerly right-of-way of County Highway 21, 40.76 feet right of station 63+82.92 on the centerline survey of existing County Highway 21 made by the Department of Highways and Recorded in Book No. 4, Pages 30-33 of the Records of Wyandot County;

Thence N 68° 23' 10.4" W, a distance of 120.90 feet along the northerly right-of-way of State Route 15, to the point of beginning.
