Commencing at a found iron rod marking the centerline of State Route 15 and County Highway 21, relocated, said rod being at Station 1307 + 50.04 on the centerline survey made in 1962 by the Ohio Department of Transportation of State Route 15, Section 0.00 in Wyandot County;

thence S 68° 53' 10.4" E, along the centerline of State Route 15, to Station 1305 + 65 of said centerline survey;

Being a parcel of land situated in the Northeast and Southeast Quarter of Section 14, Township 1 South, Range 12 East, Ridge Township, Wyandot County, Ohio and further described as follows:

Commencing at a found iron rod marking the centerline of State Route 15 and County Highway 21, relocated, said rod being at Station 1307 + 50.04 on the centerline survey made in 1962 by the Ohio Department of Transportation of State Route 15, Section 0.00 in Wyandot County;

thence S 68° 53' 10.4" E, along the centerline of State Route 15, to Station 1305 + 65 of said centerline survey; *a distance of 185.04 feet*

thence N 21° 06' 49.6" E, a distance of 150.00 feet to a found iron rod at the intersection of the right-of-ways of State Route 15 and County Highway 21, relocated, said rod being 150.00 feet right of Station 1305 + 65 of said centerline survey;

thence S 68° 23' 10.4" E, a distance of 746.65 feet along the northerly right-of-way of State Route 15 to a point and being the POINT OF BEGINNING, passing a set iron rod for reference a distance of 718.66 feet;

thence S 89° 57' 32" E, a distance of 597.21 feet along the centerline of an open ditch to a point;

thence N 03° 32' 18" E, a distance of 284.19 feet to a set iron rod, passing a set iron rod for reference at 14.71 feet;
