Commencing at a set P-K nail marking the intersection of centerlines of US 30 and TH 144 and being the POINT OF BEGINNING;

thence along the centerline of US 30, a distance of 186.69 on a curve bearing to the right with a radius of 3906.53 feet, a chord length of 186.67 feet with a bearing of N 63° 08' 05" E, to a P-K nail set;

thence S 09° 20' 25" E, a distance of 212.53 feet to a set iron rod, passing a set iron rod at 52.09 feet;

thence S 83° 39' 29" W, a distance of 202.26 feet to a set iron rod, passing a set iron rod at 182.14 feet;

thence N 00° 00' 00" E, along the centerline of TH 144, a distance of 147.70 feet to the POINT OF BEGINNING.
