thence S 90° 00' 00" E along the centerline of CH 44, a distance of 636.53 feet to a found P-K nail;

thence N 00° 00' 00" E, a distance of 306.61 feet to a found iron rod and being the POINT OF BEGINNING, passing a found iron rod at 20.00 feet;

thence N 00° 00' 00" E, a distance of 1013.18 feet to a set iron rod;

thence S 90° 00' 00" E, a distance of 696.97 feet to a set P-K nail on the centerline of TH 112, passing a set iron rod at 676.97 feet;

thence S 00° 20' 06" W along said centerline, a distance of 1319.82 feet to a set P-K nail at the intersection of centerlines of CH 44 and TH 112;

thence N 90° 00' 00" W, along the centerline of CH 44, a distance of 397.92 feet to a found P-K nail;

thence N 01° 29' 06" E, a distance of 75.55 feet to a found iron rod, passing a found iron rod at 20.01 feet;

thence N 89° 18' 35" W, a distance of 89.27 feet to a found iron rod;

thence N 00° 00' 00" W, a distance of 189.10 feet to a found iron rod;

thence N 87° 17' 45" W, a distance of 84.19 feet to a found iron rod;

thence N 00° 00' 00" E, a distance of 36.94 feet to a found iron rod;

thence S 90° 00' 00" W, a distance of 119.92 feet to the POINT OF BEGINNING.
