Commencing at a found stone in a monument box marking the North Quarter Post of said Section;

thence on an assumed bearing of S 89° 42' 20" E along the centerline of County Highway 62 a distance of 1606.80 feet to a set P-K nail and being the **POINT OF BEGINNING**;

thence continuing along said centerline S 89° 42' 20" E a distance of 435.00 feet to a P-K nail;

thence S 20° 35' 51" W along the low water line of the Sandusky River a distance of 218.81 feet to a point;

thence S 86° 58' 49" W a distance of 359.68 feet to a set iron rod, passing a set iron rod for reference a distance of 104.38 feet;

thence N 00° 17' 40" E a distance of 226.00 feet to the **POINT OF BEGINNING**, passing two set iron rods a distance of 35.50 feet and 206.00 feet respectively;

Containing in all 1.957 acres of land, more or less, of which 0.200 acre, more or less, is currently contained within the right-of-way of County Highway 62. The above described property being subject to all legal highways and easements of record.
