LEGAL DESCRIPTION

Situated in Jackson Township, County of Wyandot, State of Ohio and being a part of the SW $\frac{1}{4}$ of Section 21, T3S, R12E, a tract of land bounded and described as follows:

Beginning at a P.K. Nail set on the south line of the SW $\frac{1}{4}$ of Section 21 and described as lying S 89°36'45" W, a distance of 1304.08 feet from a P.K. Nail set marking the southeast corner of said SW $\frac{1}{4}$;

Thence from the above described point of beginning and along said south line, also being the centerline of the Township Highway #64, S 89°36'45" W, a distance of 260.00 feet to a P.K. Nail set;

Thence N 00°46'39" W, a distance of 251.31 feet to a $\frac{1}{2}$ " Rebar set;

Thence N 89°36'45" E, a distance of 200.00 feet to a $\frac{1}{2}$ " Rebar set;

Thence N 00°46'39" W, a distance of 2418.16 feet to a $\frac{1}{2}$ " Rebar set on the north line of said SW $\frac{1}{4}$ of Section 21;

Thence along said north line, N 89°55'31" E, a distance of 1372.23 feet to a $\frac{1}{2}$ " Rebar set marking the northeast corner of said SW $\frac{1}{4}$ of Section 21;

Thence along the east line of said SW $\frac{1}{4}$, S 00°36'12" E, a distance of 1330.96 feet to a $\frac{1}{2}$ " Rebar set marking the southeast corner of the NE $\frac{1}{4}$ of said SW $\frac{1}{4}$;

Thence along the south line of said NE $\frac{1}{4}$ of the SW $\frac{1}{4}$, S 89°46'09" W, a distance of 1308.15 feet to a $\frac{1}{2}$ " Rebar set marking the southwest corner of said NE $\frac{1}{4}$ of the SW $\frac{1}{4}$;

Thence along the east line of the SW $\frac{1}{4}$ of Section 21, S 00°46'39" E, a distance of 1334.57 feet to the point of beginning and containing 44.915 Acres of land, more or less, subject however to all legal highways and prior easements of record.
