Commencing at a set P-K nail marking the west quarter post of said Section 33 and the centerline of County Road 38; thence S 90° 00' 00" E two hundred forty-four and thirty-two hundredths (244.32) feet along the east-west quarter section line and said centerline to a set P-K nail, said nail marking the northeasterly corner of a 1.973 acre parcel of land as described in Deed Volume 198, page 305, Exception No. #2 in the Wyandot County Recorder's office and the northeasterly corner of said 1.973 acre parcel of land now or formerly owned by Robert and Charlotte Frederick as described in Deed Volume 167, page 729 in the Wyandot County Recorder's office;

thence S 90° 00' 00" E thirty-one and thirty-seven hundredths (31.37) feet along said east-west quarter section line and said centerline to a set P-K nail marking the northwesterly corner of a 18.938 acre parcel of land as described in Deed Volume 198, page 305, Exception No. #1 in the Wyandot County Recorder's office;

thence S 17° 00' 05" E two hundred three and twenty-two hundredths (203.22) feet along the westerly line of said 18.938 acre parcel to a found iron pipe;

thence S 10° 02' 25" E one hundred seven and thirteen hundredths (107.13) feet along the westerly line of said 18.938 acre parcel to a found iron pipe;

thence S 10° 03' 15" E one hundred nine and seventy-one hundredths (109.71) feet along the westerly line of said 18.938 acre parcel to a set iron rod;

thence N 40° 30' 16" W one hundred seventy-eight and seventy-one hundredths (178.71) feet to a set iron rod;


thence N 08° 29' 26" W one hundred forty-seven and forty-one hundredths (147.41) feet to THE POINT OF BEGINNING.
