Commencing at a found cornerstone marking the southwest corner of said section;

thence N 00° 05' 31" E along the centerline of TH 86, a distance of 320.12 feet to a set P-K nail and being the POINT OF BEGINNING;

thence continuing N 00° 05' 31" E along said centerline, a distance of 378.98 feet to a set P-K nail;

thence N 89° 44' 14" E, a distance of 294.36 feet to a set P-K nail on the centerline of SR 37, passing 2 set iron rods a distance of 20.00 feet and 258.35 feet respectfully;

thence S 33° 33' 45" E along said centerline, a distance of 177.41 feet to a set P-K nail;

thence S 06° 10' 47" W, a distance of 234.44 feet to a set iron rod, passing a set iron rod a distance of 47.22 feet;

thence N 89° 54' 29" W, a distance of 367.81 feet to the POINT OF BEGINNING.

thence S 89° 54' 29" E, a distance of 367.81 feet to a set iron rod, passing a set iron rod a distance of 20.00 feet;

thence S 06° 10' 47" W, a distance of 319.86 feet to a point referenced by a set iron rod S 89° 44' 14" W, a distance of 3.00 feet;

thence S 89° 44' 14" W, a distance of 333.90 feet to the POINT OF BEGINNING, passing a set iron rod a distance of 3.00 feet.
