thence S 89° 44' 14" W, a distance of 290.14 feet to a set iron rod, passing a set iron rod a distance of 36.01 feet;

thence N 06° 10' 47" E, a distance of 379.30 feet to a set P-K nail on the centerline of SR 37, passing (2) two found iron rods a distance of 144.86 feet and 332.08 feet respectively;

thence S 33° 33' 45" E along said centerline, a distance of 450.94 feet to the POINT OF BEGINNING.
