thence continuing N 00° 00' 45" E along the westerly line of said inlot, a distance of 99.24 feet to a set iron rod on the northerly line of said inlot;

thence N 89° 58' 40" E along said northerly line, a distance of 55.24 feet to a set railroad spike in asphalt pavement on the easterly line of said inlot;

thence S 00° 00' 56" W along said easterly line, a distance of 99.25 feet to a set iron rod;

thence S 89° 59' 20" W, a distance of 55.24 feet to the POINT OF BEGINNING.
