thence S 90° 00' 00" W along the centerline of SR 182, a distance of 666.48 feet to a found P-K nail and being the POINT OF BEGINNING;

thence S 05° 51' 20" W, a distance of 348.22 feet to a set iron rod on the northerly line of Consolidated Rail Corporation, passing a set iron rod a distance of 25.13 feet;

thence N 85° 29' 40" W along said line, a distance of 298.55 feet to a set iron rod;

thence N 01° 30' 00" E, a distance of 323.06 feet to a set P-K nail on the centerline of SR 182, passing a set iron rod a distance of 298.05 feet;

thence N 90° 00' 00" E along said centerline, a distance of 324.69 feet to the POINT OF BEGINNING;

thence N 85° 29' 40" W along said line, a distance of 329.85 feet to a point referenced by a found iron rod w/ a yellow plastic cap ("Makeever & Associates") bearing S 15° 53' 21" W, a distance of 0.45 feet;
