SITUATED IN THE STATE OF OHIO, COUNTY OF WYANDOT, TOWNSHIP OF EDEN AND BEING PART OF THE SOUTHEAST QUARTER OF SECTION 6 TOWNSHIP 2 SOUTH, RANGE 15 EAST AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS: COMMENCING AT A MONUMENT BOX FOUND AT THE SOUTHEAST CORNER OF SAID SECTION, THENCE ON AN ASSUMED BEARING OF NORTHO 00 DEGREES 00 MINUTES 00 SECONDS EAST ALONG THE EAST SECTION LINE AND THE CENTER-LINE OF COUNTY ROAD NUMBER 134 FOR A DISTANCE OF 1,288.13 FEET TO A P.K. NAIL SET, THE PLACE OF BEGINNING.
