SURVEY DESCRIPTION

1.164 ACRES

Situated in the Township of Eden, County of Wyandot, State of Ohio, and being a part of the Southwest Quarter Section Ten (10), of Township Two (2) South, Range Fifteen (15) East, and being more particularly bounded and described as follows:

Commencing at a P.K. nail found over a stone and monument box at the Southwest Corner of Section 10, said point also being the intersecting Centerlines of State Route 231 and County Highway 44, thence North $86^{\circ}-30'-00''$ East along and with the South Line of Section 10 and the Centerline of Co. Hwy. 44, a distance of 166.29 feet to a railroad spike set at the Place of Beginning;

Thence North $00^{\circ}-27'-15''$ East, parallel with the West Line of Section 10 and the Centerline of St. Rt. 231, passing over an iron pin set at 20.00 feet, a distance of 233.14 feet to an iron pin set;

Thence North $86^{\circ}-30'-00''$ East, parallel with the South Line of Section 10 and the Centerline of Co. Hwy. 44, a distance of 218.03 feet to an iron pin set in an Existing property line;

Thence South $00^{\circ}-27'-15''$ West, along and with an existing property line, parallel with the West Line of Section 10 and the Centerline of State Route 231, passing over an iron pin set at 210.49 feet, a distance of 233.14 feet to a railroad spike set in the South Line of Section 10 and the Centerline of Co. Hwy. 44;

Thence South $86^{\circ}-30'-00''$ West, along and with the South Line of Section 10 and the centerline of Co. Hwy. 44, a distance of 218.03 feet to the Place of Beginning.

Containing 1.164 Acres of land more or less and subject to legal highways, easements, and restrictions of record.

All points designated "iron pin set" have a 5/8 inch diameter, epoxy coated rebar in place with a yellow plastic cap bearing the inscription "Jacques Glaze Surveyor 6817."

The foregoing description was prepared from an actual field survey completed on November 15th, 1998 by Jacques M. Glaze, Registered Surveyor No. 6817, and field assistant Marden T. Watts.
