LEGAL DESCRIPTION

FOR: Ralph Pratt

2.000 Acres

Situated in Ridge Township, County of Wyandot, State of Ohio and being a part of the N½ of the SW¼ of Section 13, T 1 S, R 12 E, a tract of land bounded and described as follows:

Beginning at a P.K. nail set marking the intersection of the east line of the SW¼ of Section 13 with the south right-of-way line of the (Abandoned) Cincinnati, Sandusky & Cleveland Railroad, said beginning point described as lying, S00°04'50"E, a distance of 91.34 feet from a P.K. nail found marking the northeast corner of the SW¼ of said Section 13, said P.K. nail found referenced by an iron pin set described as lying, S89°55'10"W, a distance of 20.00 feet;

thence along said east line, also being the centerline of C.H. 95, S00°04'50"E, a distance of 240.00 feet to a P.K. nail set;

thence at right angles, S89°55'10"W, a distance of 282.48 feet to an iron pin set and passing an iron pin set at 20.00 feet;

thence parallel with the east line of said SW¼, N00°04'50"W, a distance of 376.81 feet to an iron pin set on the south right-of-way line of the (Abandoned) Cincinnati, Sandusky & Cleveland Railroad;

thence along said south right-of-way line, S64°14'21"E, a distance of 313.87 feet to the point of beginning and passing an iron pin set 22.22 feet, northwesterly thereof, said tract containing 2.000 acres of land, more or less, of which 0.049 acres lies in the NW¼ of Section 13 and 1.951 acres lies in the SW¼ of Section 13, said tract subject however to all legal highways and prior easements of record.
