COMMENCING AT A RAILROAD SPIKE FOUND AT THE INTERSECTION OF THE CENTERLINE OF STATE ROUTE 568 WITH THE CENTERLINE OF TOWNSHIP HIGHWAY 95 [NORTH-SOUTH HALF SECTION LINE OF SAID SECTION] WHICH HAS A HALF INCH IRON PIPE WITH 5647 CAP SET SOUTH 65 DEGREES 18 MINUTES 29 SECONDS WEST AND 34.32 FEET DISTANT] .

THENCE ON AN ASSUMED BEARING OF NORTH 44 DEGREES, 40 MINUTES, 58 SECONDS WEST (THIS BEARING IS ASSUMED AND ALL OTHER BEARINGS ARE FROM ANGLES AND DISTANCES MEASURED IN THE FIELD) ALONG THE CENTERLINE OF STATE ROUTE 568 FOR A DISTANCE OF 286.63 FEET TO A HALF INCH DIAMETER HEAD METAL NAIL FOUND ON THE MARY BOWERSOCK [O. R. BOOK 134 PG.313] SOUTHEAST LINE AND HAVING A HALF INCH PERSONALIZED IRON PIPE WITH CAP SET SOUTH 35 DEGREES, 05 MINUTES, 17 SECONDS WEST AND AT A DISTANCE OF 30.55 FEET] .

THENCE NORTH 44 DEGREES, 35 MINUTES, 17 SECONDS WEST ALONG THE CENTERLINE OF STATE ROUTE 568 FOR A DISTANCE OF 177.82 FEET TO A HALF INCH DIAMETER HEAD METAL NAIL FOUND ON THE MARY BOWERSOCK [O. R. BOOK 134 PG.313] NORTHWEST LINE, THE PLACE OF BEGINNING [AND SAID PLACE HAVING A HALF INCH PERSONALIZED IRON PIPE WITH CAP SET SOUTH 35 DEGREES, 03 MINUTES, 38 SECONDS WEST AND AT A DISTANCE OF 31.34 FEET] .

THENCE SOUTH 35 DEGREES, 03 MINUTES, 38 SECONDS WEST ON SAID LINE FOR A DISTANCE OF 200.01 FEET TO A ONE INCH IRON PIPE FOUND ON SAID BOWERSOCK SOUTHWEST LINE.

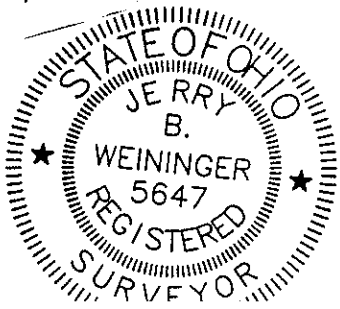

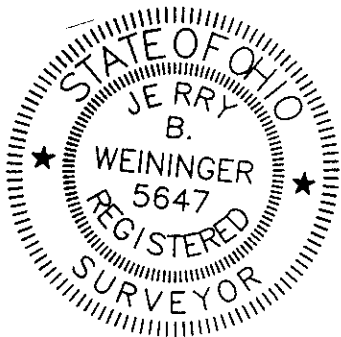
