**LEGAL DESCRIPTION OF A 2.000 ACRE PARCEL
FOR BRETT & BRAD MANNS**

Being a parcel of land situated in part of the Northeast Quarter of Section 24 T-1-S,
R-13-E, Crawford Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found wood post marking the East Quarter Post of said Section 24 and
referenced by a found iron rod situated S 00° 23' 16" W a distance of 1.86 feet;

thence N 00° 46' 56" E along the east line of said Section 24 a distance of 197.37 feet to
a found MAG nail marking the southeast corner of a parcel of land now or currently
owned by D. Wheeler, Etux. passing a found iron rod a distance of 171.72 feet;

thence N 89° 25' 15" W along the south line of said Wheeler parcel a distance of 117.93
feet to a found MAG nail referenced by a found iron rod situated N 61° 43' 54" W a
distance of 61.92 feet;

thence S 87° 15' 26" W along the south line of said Wheeler parcel a distance of 54.90
feet to a found MAG nail marking the southwest corner of said Wheeler parcel and being
the **POINT OF BEGINNING** of the hereinafter described parcel referenced by a found
iron rod situated N 00° 32' 32" E a distance of 31.95 feet;

thence S 00° 32' 32" W a distance of 3.11 feet to a point marking the centerline of State
Highway 103 referenced by a found iron rod situated N 00° 32' 32" E a distance of 35.06
feet;

thence S 86° 30' 08" W along the centerline of said State Highway 103 a distance of
45.27 feet to a found MAG nail, referenced by a found iron rod situated N 50° 16' 41" E
a distance of 59.18 feet;

thence along said centerline an arc distance of 187.50 feet on a curve to the left having a
radius of 716.20 feet, a chord distance of 186.97 feet and a chord bearing of S 79° 00'
08"W to a found MAG nail referenced by a set iron rod situated N 58° 44' 08" W a
distance of 92.90 feet;

thence S 71° 30' 08" W along said centerline a distance of 84.48 feet to a set MAG nail;

thence N 00° 32' 32" E a distance of 307.78 feet to a set iron rod, passing a set iron rod a distance of 75.02 feet;

thence N 83° 48' 42" E a distance of 310.35 feet to a set iron rod marking the west line of said Wheeler parcel;

thence S 00° 32' 32" W along said line a distance of 272.89 feet to the **POINT OF BEGINNING**, passing a found iron rod a distance of 240.94 feet.

Containing in all 2.000 acres of land, more or less, of which 0.405 acre, more or less, is currently contained within highway right-of-ways. The above described property being subject to all legal highways and easements of record.

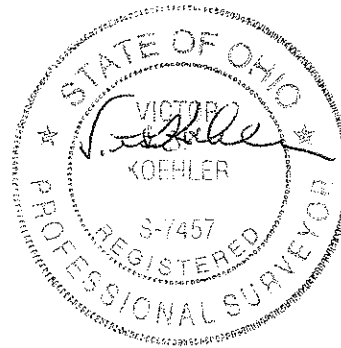
Bearings are assumed and are for angular measurement only.
