thence S 01° 07' 42" W along the east line of said Lot #5 a distance of 50.00 feet to a found iron rod marking the southeast corner of said Lot #5;

thence N 88° 32' 08" W along the south line of said Lot #5 a distance of 160.15 feet to the **POINT OF BEGINNING**.
