**LEGAL DESCRIPTION OF A 0.408 ACRE PARCEL  
FOR JORDAN RALL**

Being a parcel of land situated in part of the Northwest Quarter of Section 24, T-3-S, R-13-E, Mifflin Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found stone marking the northwest corner of said Section 24;

thence on an assumed bearing of S 00° 00' 16" W along the west line of said Section 24 and the centerline Township Highway 108 a distance of 38.00 feet to a found MAG nail marking a corner of a parcel of land now or formerly owned by J. Rall, Etal, and being the **POINT OF BEGINNING** of the hereinafter described parcel, referenced by a found iron rod situated N 89° 01' 18" E a distance of 30.00 feet;

thence N 89° 01' 18" E along said Rall parcel a distance of 296.00 feet to a found iron rod marking a corner of said Rall parcel, passing the aforementioned found iron rod a distance of 30.00 feet;

thence S 01° 01' 17" E on a line a distance of 60.00 feet to a set iron rod;

thence S 89° 01' 18" W on a line a distance of 297.07 feet to a set MAG nail marking the west line of said Section 24 and the centerline of Township Highway 108, passing a set iron rod a distance of 267.07 feet;

thence N 00° 00' 16" E along the west line of said Section 24 and the centerline of said Township Highway 108 a distance of 60.00 feet to the **POINT OF BEGINNING**.

Containing in all 0.408 acre of land, more or less, of which 0.041 acre, more or less, is currently contained within highway right-of-ways. The above described property being subject to all legal highways and easements of record.

Bearings are assumed and are for angular measurement only.

All set iron rods are 5/8" diameter with personalized plastic caps.
