**LEGAL DESCRIPTION OF A 4.537 ACRE PARCEL
FOR DOUG WALTON**

Being a parcel of land situated in part of the Southwest Quarter of Section 14, T-1-S, R-14-E, Tymochtee Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found nail marking the intersection of the centerlines of County Highway 35 and County Highway 37 and being the **POINT OF BEGINNING** of the hereinafter described parcel, referenced by a found iron rod situated S 34° 31' 27" W a distance of 33.85;

thence on an assumed bearing of N 28° 24' 43" W along the centerline of said County Highway 35 a distance of 794.00 feet to a set MAG nail, referenced by a set iron rod situated S 75° 13' 38" E a distance of 41.14 feet;

thence S 75° 13' 38" E on a line a distance of 302.07 feet to a set iron rod, passing the aforementioned set iron rod a distance of 41.14 feet;

thence S 63° 05' 24" E on a line a distance of 427.62 feet to a set MAG nail marking the centerline of County Highway 37, passing a found iron rod for reference a distance of 397.34 feet;

thence S 34° 38' 40" W along the centerline of said County Highway 37 a distance of 520.00 feet to the **POINT OF BEGINNING**.

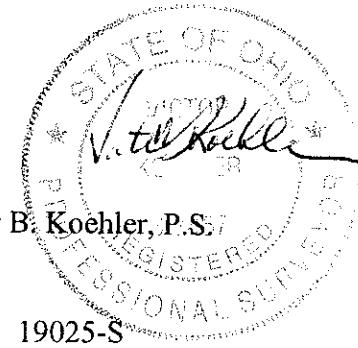

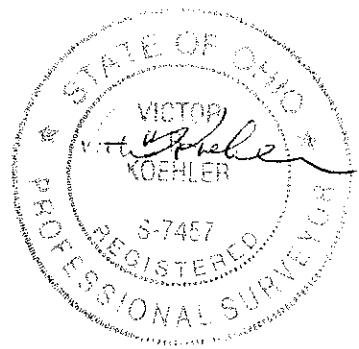
