**LEGAL DESCRIPTION OF A 5.010 ACRE PARCEL
FOR SHANE STANSBERRY**

Being a parcel of land situated in part of the Southeast Quarter of Section 15, T-1-S, R-14-E, Tymochtee Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found monument box marking the southeast corner of said Section 15 and the centerline of State Highway 103 and being the **POINT OF BEGINNING** of the hereinafter described parcel;

thence on an assumed bearing of N 88° 59' 30" W along the south line of said Section 15 and the centerline of said State Highway 103 a distance of 490.00 feet to a set MAG nail, referenced by a set iron rod situated N 00° 14' 56" W a distance of 30.01 feet;

thence N 00° 14' 56" W on a line a distance of 445.50 feet to a set iron rod, passing the aforementioned set iron rod a distance of 30.01 feet;

thence S 88° 59' 30" E on a line a distance of 490.00 feet to a set iron rod marking the east line of said Section 15;

thence S 00° 14' 56" E along the east line of said Section 15 a distance of 445.50 feet to the **POINT OF BEGINNING**.

Containing in all 5.010 acres of land, more or less, of which 0.337 acre, more or less, is currently contained within highway right-of-ways. The above described property being subject to all legal highways and easements of record.

Bearings are assumed and are for angular measurement only.

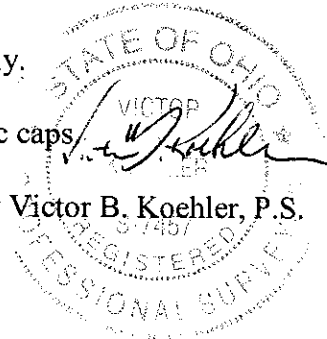
All set iron rods are 5/8" diameter with personalized plastic caps
