**LEGAL DESCRIPTION OF A 0.293 ACRE PARCEL
FOR JEFF VAN BEVEREN**

Being a parcel of land situated in part of the Southeast Quarter of Section 33, T-1-S,
R-15-E, Sycamore Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found stone marking the southeast corner of said Section 33;

thence on an assumed bearing of N 00° 00' 11" W along the centerline of State Route
231 a distance of 1925.10 feet to a found railroad spike marking the northeast corner of a
parcel of land now or formerly owned by J. Van Beveren and being the **POINT OF
BEGINNING** of the hereinafter described parcel, referenced by a found iron pipe
situated S 89° 59' 31" W a distance of 30.00 feet;

thence S 89° 59' 31" W along the north line of said J. Van Beveren parcel a distance of
255.00 feet to a found iron pipe marking the northwest corner of said J. Van Beveren
parcel, passing the aforementioned found iron pipe a distance of 30.00 feet;

thence N 00° 00' 11" W on a line a distance of 50.00 feet to a set iron rod;

thence N 89° 59' 31" E on a line a distance of 255.00 feet to a set MAG nail marking the
centerline of said State Highway 231, passing a set iron rod a distance of 225.00 feet;

thence S 00° 00' 11" E along the centerline of said State Highway 231 a distance of
50.00 feet to the **POINT OF BEGINNING**.

Containing in all 0.293 acres of land, more or less, of which 0.034 acre, more or less, is
currently contained within highway right-of-ways. The above described property being
subject to all legal highways and easements of record.

Bearings are assumed and are for angular measurement only.

All set iron rods are 5/8" diameter with personalized plastic caps.

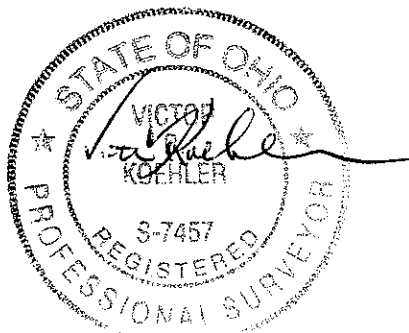
