thence on an assumed bearing of S 89° 56' 21" W along the south line of said Inlot #35 a distance of 166.22 feet to a set iron rod marking the southwest corner of said Inlot #35;

thence N 00° 01' 25" W along the west line of said Inlot #35 and Inlot #38 a distance of 84.00 feet to a set iron rod;

thence N 89° 56' 16" E on a line a distance of 166.19 feet to a set iron rod marking the east line of said Inlot #38;

thence S 00° 02' 51" E along the east line of said Inlot #38 and Inlot #35 a distance of 84.00 feet to the **POINT OF BEGINNING**.

Containing in all 0.321 acres of land, more or less. The above described property being subject to all legal highways and easements of record.



Commencing at a set MAG nail marking the northeast corner of said Inlot #53 and being the **POINT OF BEGINNING** of the hereinafter described parcel, referenced by a set iron rod situated S 00° 02' 51" E a distance of 10.00 feet;

thence on an assumed bearing of S 00° 02' 51" E along the east line of said Inlot #53 and Inlot #38 a distance of 114.00 feet to a set iron rod, passing the aforementioned set iron rod a distance of 10.00 feet;

thence S 89° 56' 16" W on a line a distance of 166.19 feet to a set iron rod marking the west line of said Inlot #38;

thence N 00° 01' 25" W along the west line of said Inlot #38 and Inlot #53 a distance of 114.00 feet to a set iron rod marking the northwest corner of said Inlot #53;

thence N 89° 56' 16" E along the north line of said Inlot #53 a distance of 166.14 feet to the **POINT OF BEGINNING**.


