**LEGAL DESCRIPTION OF A 2.000 ACRE PARCEL
FOR D. POOL, TRUSTEE**

Being a parcel of land situated in part of the Southeast Quarter of Section 15, T-3-S,
R-13-E, Mifflin Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found stone marking the center of said Section 15 and the centerline of
Township Highway 103 and being the **POINT OF BEGINNING** of the hereinafter
described parcel;

thence on an assumed bearing of N 87° 34' 39" E along the east-west half section line of
said Section 15 a distance of 295.21 feet to a set iron rod;

thence S 01° 00' 00" E on a line a distance of 295.21 feet to a set iron rod;

thence S 87° 34' 39" W on a line a distance of 295.21 feet to a set MAG nail marking the
north-south half section line of said Section 15 and the centerline of said Township
Highway 103, passing a set iron rod a distance of 275.20 feet;

thence N 01° 00' 00" W along the north-south half section line of said Section 15 and the
centerline of said Township Highway 103 a distance of 295.21 feet to the **POINT OF
BEGINNING.**

Containing in all 2.000 acres of land, more or less, of which 0.136 acre, more or less, is
currently contained within highway right-of-ways. The above described property being
subject to all legal highways and easements of record.

Bearings are assumed and are for angular measurement only.


All set iron rods are 5/8" diameter with personalized plastic caps.


