**LEGAL DESCRIPTION**

Vaughn Property Services, LLC

2.027 acres

Situated in the Village of Carey, County of Wyandot, State of Ohio and being a part of Lot 4 as platted in the Sheridan Subdivision recorded in Cabinet A, Slides 768 and 769 in the Wyandot County Recorder's Office, a tract of land bounded and described as follows:

Beginning at a 5/8" iron pin found with PAI cap marking the northeast corner of said Lot 4;

thence along the east line of said Lot 4 S01°10'01"W a distance of 232.40 feet to an iron pin set;

thence parallel with the north line of said Lot 4 N88°52'10"W a distance of 379.82 feet to a 5/8" iron pin found with PAI cap on the east right of way line of Summer Drive (60' R/W) as platted in said Sheridan Subdivision and marking the PT of a curve;

thence along the east right of way line of said Summer Drive N01°07'50"E a distance of 232.40 feet to a 1/4" drill hole set in a concrete sidewalk marking the northwest corner of said Lot 4, referenced by an iron pin set N88°52'10"W a distance of 3.00 feet;

thence along the north line of said Lot 4 S88°52'10"E a distance of 379.97 feet to the Point of Beginning and containing 2.027 acres of land, more or less, subject however to all prior easements of record.


