**LEGAL DESCRIPTION OF A 2.407 ACRE PARCEL
FOR HARVEY STANSBERRY**

Being a parcel of land situated in part of the Southwest Quarter of Section 18, T-4-S,
R-13-E, Marseilles Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found stone marking the intersection of the centerlines of County
Highway 142A and County Highway 142;

thence on an assumed bearing of S 42° 57' 47" W along the centerline of said County
Highway 142 a distance of 3158.74 feet to a found railroad spike marking intersection of
the north-south half section line of said Section 18 and the centerline of said County
Highway 142;

thence S 43° 03' 54" W along the centerline of said County Highway 142 a distance of
100.01 feet to a set MAG nail and being the **POINT OF BEGINNING** of the hereinafter
described parcel, referenced by a set iron rod situated N 55° 51' 13" W a distance of
30.37 feet;

thence continuing S 43° 03' 54" W along the centerline of said County Highway 142 a
distance of 341.83 feet to a set MAG nail, referenced by a set iron rod situated N 35° 33'
10" W a distance of 40.00 feet;

thence N 35° 33' 10" W on a line a distance of 377.85 feet to a set iron rod, passing the
aforementioned set iron rod a distance of 40.00 feet;

thence N 35° 39' 01" E on a line a distance of 206.68 feet to a set iron rod;

thence S 55° 51' 13" E on a line a distance of 401.95 feet to the **POINT OF
BEGINNING**, passing a set iron rod a distance of 371.58 feet.

Containing in all 2.407 acres of land, more or less, of which 0.232 acre, more or less, is
currently contained within highway right-of-ways. The above described property being
subject to all legal highways and easements of record.
