thence S 00° 07' 22" W on a line a distance of 66.97 feet to a set iron rod;

thence S 42° 36' 47" W on a line a distance of 222.06 feet to a found iron rod marking the west line of said Section 22;

thence N 00° 07' 22" E along the west line of said Section 22 a distance of 229.82 feet to the **POINT OF BEGINNING**.
