**LEGAL DESCRIPTION OF A 2.000 ACRE PARCEL
FOR ALTER FARM**

Being a parcel of land situated in part of the Southeast Quarter of Section 10, T-3-S, R-12-E, Jackson Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found stone marking the southeast corner of said Section 10 and the centerline of Township Highway 58;

thence on an assumed bearing of N 89° 28' 18" W along the south line of said Section 10 and the centerline of said Township Highway 58 a distance of 1511.00 feet to a set MAG nail and being the **POINT OF BEGINNING** of the hereinafter described parcel, referenced by a set iron rod situated N 00° 31' 42" E a distance of 20.00 feet;

thence continuing N 89° 28' 18" W along the south line of said Section 10 and the centerline of said Township Highway 58 a distance of 328.76 feet to a set MAG nail;

thence N 00° 31' 42" E on a line a distance of 265.00 feet to a set iron rod, passing a set iron rod a distance of 20.00 feet;

thence S 89° 28' 18" E on a line a distance of 328.76 feet to a set iron rod;

thence S 00° 31' 42" W on a line a distance of 265.00 feet to the **POINT OF BEGINNING**, passing a set iron rod a distance of 245.00 feet.

Containing in all 2.000 acres of land, more or less, of which 0.151 acre, more or less, is currently contained within highway right-of-ways. The above described property being subject to all legal highways and easements of record.

Bearings are assumed and are for angular measurement only.

All set iron rods are 5/8" diameter with personalized plastic caps.
