**LEGAL DESCRIPTION OF A 5.010 ACRE PARCEL
FOR MARK KOEHLER**

Being a parcel of land situated in part of the Northwest Quarter of Section 8, T-2-S, R-14-E, Crane Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found stone marking the northwest corner of said Section 8 and the centerline of County Highway 42 and being the **POINT OF BEGINNING** of the hereinafter described parcel;

thence on an assumed bearing of S 89° 08' 14" E along the north line of said Section 8 and the centerline of said County Highway 42 a distance of 845.40 feet to a set MAG nail;

thence S 00° 21' 09" W on a line a distance of 262.95 feet to the centerline of an open ditch, passing two set iron rods at distances of 20.00 feet and 242.95 feet, respectively;

thence N 89° 08' 14" W along the centerline of said open ditch a distance of 418.73 feet to a point, referenced by a set iron rod situated N 06° 42' 51" E a distance of 20.00 feet;

thence N 86° 34' 51" W along the centerline of said open ditch a distance of 427.27 feet to a point marking the west line of said Section 8;

thence N 00° 21' 09" E along the west line of said Section 8 a distance of 243.89 feet to the **POINT OF BEGINNING**, passing a set iron rod a distance of 7.90 feet.

Containing in all 5.010 acres of land, more or less, of which 0.388 acre, more or less, is currently contained within highway right-of-ways. The above described property being subject to all legal highways and easements of record.

Bearings are assumed and are for angular measurement only.

All set iron rods are 5/8" diameter with personalized plastic caps.
