**LEGAL DESCRIPTION OF A 1.813 ACRE PARCEL
FOR WYANDOT COUNTY AIRPORT AUTHORITY**

Being a parcel of land situated part of the Northeast Quarter of Section 12, T-2-S, R-13-E, Salem Township, Wyandot County, Ohio, and further described as follows:

Beginning at a found stone marking the north quarter post of said Section 12 and the centerline of County Highway 42 and being the **POINT OF BEGINNING** of the hereinafter described parcel;

thence on an assumed bearing of N 89° 44' 50" E along the north line of said Section 12 and the centerline of County Highway 42 a distance of 378.00 feet to a set MAG nail;

thence S 00° 11' 18" W on a line a distance of 220.00 feet to a set iron rod, passing a set iron rod a distance of 20.00 feet;

thence S 89° 44' 50" W on a line a distance of 200.00 feet to a set MAG nail referenced by a set iron rod situated N 00° 11' 18" E a distance of 23.50 feet;

thence N 00° 11' 18" E on a line a distance of 23.50 feet to a set iron rod;

thence S 89° 44' 50" W on a line a distance of 178.00 feet to a set iron rod marking the east line of a parcel of land now or formerly owned by Wyandot County, Ohio;

thence N 00° 11' 18" E along said Wyandot County, Ohio parcel a distance of 196.50 feet to the **POINT OF BEGINNING**.

Containing in all 1.813 acres of land, more or less, of which 0.174 acre, more or less, is currently contained within highway right-of-ways. The above described property being subject to all legal highways and easements of record.

Bearings are assumed and are for angular measurement only.

All set iron rods are 5/8" diameter with personalized plastic caps.
