**LEGAL DESCRIPTION OF A 2.335 ACRE PARCEL
FOR LINK COLE**

Being a parcel of land situated in part of the Northeast Quarter of Section 24, T-2-S, R-14-E, Eden Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found stone marking the northeast corner of said Section 24 and the intersection of the centerlines of County Highway 128 and County Highway 47;

thence on an assumed bearing of S 00° 05' 27" W along the east line of said Section 24 and the centerline of said County Highway 128 a distance of 663.27 feet to a set MAG nail and being the **POINT OF BEGINNING** of the hereinafter described parcel, referenced by a set iron rod situated S 89° 26' 45" W a distance of 20.00 feet;

thence continuing S 00° 05' 27" W along the east line of said Section 24 and the centerline of said County Highway 128 a distance of 314.00 feet to a set MAG nail;

thence N 89° 17' 45" W on a line a distance of 312.00 feet to a set iron rod, passing a set iron rod a distance of 20.00 feet;

thence N 17° 30' 34" W on a line a distance of 127.59 feet to a set iron rod;

thence N 15° 19' 45" E on a line a distance of 192.43 feet to a set iron rod;

thence N 89° 26' 45" E on a line a distance of 300.00 feet to the **POINT OF BEGINNING**, passing a set iron rod a distance of 280.00 feet.

Containing in all 2.335 acres of land, more or less, of which 0.144 acre, more or less, is currently contained within highway right-of-ways. The above described property being subject to all legal highways and easements of record.

Bearings are assumed and are for angular measurement only.

All set iron rods are 5/8" diameter with personalized plastic caps.
