BEGINNING at a set iron rod marking the northwesterly corner of said Lot 35; thence S 89° 57' 01" E ninety and zero hundredths (90.00) feet along the northerly line of said Lot 35 to a set iron rod;

thence S 00° 10' 37" E one hundred twenty and fifty-four hundredths (120.54) feet to a set iron rod marking the southerly line of said Lot 34;

thence N 89° 57' 01" W ninety and zero hundredths (90.00) feet along the southerly line of said Lot 34 to a set iron rod marking the southwesterly corner thereof;

thence N 00° 10' 37" W one hundred twenty and fifty-four hundredths (120.54) feet along the westerly line of said Lot 34 and said Lot 35 to THE POINT OF BEGINNING.

Containing in all, 0.249 acres of land, more or less, subject to all legal highways and easements.

thence S $89^{\circ} 57' 01''$ E ninety and zero hundredths (90.00) feet along the northerly line of said Lot 35 to THE POINT OF BEGINNING.
