Being a parcel of land situated in part of the southwest quarter of section 26, T-3-S, R-14-E, Pitt Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found concrete monument marking station 251+22.19 of ODOT Right-of-Way plans (Wya. 23-0.20);

thence S 62° 36' 35" E along the centerline of US 23, a distance of 1222.19 feet to a found iron rod, passing a found concrete monument at station 245+00.00, a distance of 622.19 feet;

thence N 27° 23' 25" E, a distance of 93.78 feet to a found iron rod on the Limited Access Right-of-Way of US 23;

thence N 64° 43' 43" W along said Limited Access Right-of-Way, a distance of 100.07 feet to a found iron rod;

thence N 62° 36' 35" W along said Limited Access Right-of-Way, a distance of 133.89 feet to a found iron rod;

thence N 26° 20' 44" E, a distance of 17.50 feet to a set P-K nail in the pavement of CH 113 and being the POINT OF BEGINNING;

thence N 26° 20' 44" E, a distance of 292.26 feet to a set iron rod;

thence S 89° 58' 03" E, a distance of 500.04 feet to a set P-K nail on centerline of TH 124, passing a set iron rod a distance of 456.29;

thence S 00° 30' 56" E along said centerline, a distance of 221.70 feet to a found P-K nail;

thence S 69° 49' 35" W, a distance of 234.35 feet to a found P-K nail;

thence S 78° 41' 10" W, a distance of 75.15 feet to a found P-K nail in the pavement of CH 113;

thence S 86° 33' 43" W, a distance of 85.36 feet to a found P-K nail in the pavement of CH 113;

thence N 85° 33' 13" W, a distance of 74.96 feet to a found P-K nail in the pavement of CH 113;

thence N 78° 43' 26" W, a distance of 66.58 feet to a found P-K nail in the pavement of CH 113;

thence N 72° 14' 48" W, a distance of 62.39 feet to a found P-K nail in the pavement of CH 113;

thence N 66° 47' 42" W, a distance of 58.12 feet to the POINT OF BEGINNING.

thence N 27° 23' 25" E, a distance of 93.78 feet to a found iron rod on the Limited Access Right-of-Way of US 23;

thence N 64° 43' 43" W along said Limited Access Right-of-Way, a distance of 100.07 feet to a found iron rod;

thence N 62° 36' 35" W along said Limited Access Right-of-Way, a distance of 133.89 feet to a found iron rod;

thence N 26° 20' 44" E, a distance of 309.76 feet to a set iron rod and being the POINT OF BEGINNING, passing a found P-K nail a distance of 17.50 feet;
