thence S 00° 18' 00" W, a distance of 212.30 feet to a set iron rod and being the POINT OF BEGINNING;

thence S 83° 29' 00" E, a distance of 334.60 feet to a set iron rod;

thence S 03° 45' 00" W, a distance of 293.00 feet to a set iron rod, passing a set iron rod a distance of 175.00 feet;

thence N 85° 23' 49" W, a distance of 315.89 feet to a set iron rod;

thence N 00° 18' 00" E, a distance of 305.00 feet to the POINT OF BEGINNING, passing a set iron rod a distance of 130.00 feet.
