Commencing at a set iron rod at Station 1060+53.30 (USR 23) marking the intersection of centerlines of Township Highway 98 and United States Route 23;

thence S 00° 55' 08" E along the centerline of Township Highway 98 a distance of 1176.78 feet to a set P-K nail and being the POINT OF BEGINNING;

thence N 89° 41' 05" E a distance of 270.00 feet to a set iron rod, passing a set iron rod a distance of 20.00 feet;

thence S 00° 55' 08" E a distance of 225.00 feet to a set iron rod;

thence S 89° 41' 05" W a distance of 270.00 feet to a set iron rod on the centerline of Township Highway 98, passing a set iron rod a distance of 250.00 feet;

thence N 00° 55' 08" W along the centerline of Township Highway 98 a distance of 225.00 feet to POINT OF BEGINNING;

Containing in all 1.395 acres of land, more or less, subject to all legal highways and easements of record.
