Commencing at a set iron rod marking the northeast corner of said Inlot #86;

thence on an assumed bearing of S 89° 59' 06" W along the north line of said Inlot a distance of 99.23 feet to a set iron rod and being the **POINT OF BEGINNING**;

thence S 00° 02' 45" E a distance of 22.08 feet to a set iron rod;

thence S 89° 59' 06" W a distance of 66.00 feet to a drill hole in a concrete sidewalk on the west line of said Inlot;

thence N 00° 02' 45" W along said line a distance of 22.08 feet to a point on the north line of said Inlot referenced by a drill hole in the concrete sidewalk located S 89° 59' 06" W a distance of 1.00 foot;

thence N 89° 59' 06" E along said line a distance of 66.00 feet to the **POINT OF BEGINNING**;

Containing in all 0.0335 acres of land, more or less, subject to all legal highways and easements of record.
