

DESCRIPTION OF 1.832 ACRE ARTHUR P. NORRIS TRACT

Being a tract of land situated in the Northwest corner of the West one half of the West one half of the Northeast Quarter of Section 5, Township 2 South, Range 15 East, Eden Township, Wyandot County, State of Ohio and more particularly described as follows:

Commencing at a P.K. nail found over a stone in a cast iron monument box at the Northeast corner of Section 5; said point being at the intersection of the centerline of Township Highway 136-A to the South, with the centerline of County Highway 39-D, East and West.

Thence N. $89^{\circ} 55' 55''$ W. on the North line of Section 5, also being the centerline of County Highway 39-D, a distance of 1981.55 feet to a stone found in a cast iron monument box at the Northeast corner of the West one half of the West one half of the Northeast Quarter of Section 5;

Thence N. $89^{\circ} 54' 50''$ W. on the North line of Section 5, also the centerline of County Highway 39-D a distance of 449.76 feet to a railroad spike set at the TRUE POINT OF BEGINNING for the herein described tract.

Thence S. $00^{\circ} 02' 40''$ W. a distance of 380.00 feet to a $5/8$ inch diameter iron pin set (passing over a $5/8$ inch diameter iron pin set at 30.00 feet).

Thence N. $89^{\circ} 54' 50''$ W. a distance of 210.00 feet to a $5/8$ inch diameter iron pin set on the North and South mid Section line of Section 5.

Thence N, $00^{\circ} 02' 40''$ E. on the mid Section line of Section 5 a distance of 380.00 feet to an iron pin found set in concrete and in a cast iron monument box; said point being at the Northwest corner of the Northeast Quarter of Section 5 and also on the centerline of County Highway 39-D . This course passing over a $5/8$ inch diameter iron pin set at 350.00 feet;

Thence S. $89^{\circ} 54' 50''$ E. on the North line of Section 5, also the centerline of County Highway 39-D a distance of 210.00 feet to the POINT OF BEGINNING (passing by an iron pin found set in concrete and in a cast iron monument box. The said iron pin being 0.07 feet North of this line at a distance of 60.05 feet);



All 5/8 inch diameter iron pins noted as being set have a yellow plastic identity cap marked RLS 4386.
