**LEGAL DESCRIPTION OF A 0.134 ACRE PARCEL
FOR JOHN STONE AND JANE COOPER LAMBERT**

Being a parcel of land situated in part of Lot 42 of the Original Plat of the Village of Nevada and part of Lots 19 & 20 of Goodbread's First Addition to the Village of Nevada, Wyandot County, Ohio, and further described as follows:

Commencing at a set iron rod marking the intersection of the westerly right-of-way line of Garrett Street and the northerly right-of-way line of Wolfe Street;

thence on an assumed bearing of N 88° 45' 20" W along the northerly right-of-way line of Wolfe Street a distance of 82.00 feet to a set iron rod and being the **POINT OF BEGINNING**;

thence on an assumed bearing of N 88° 45' 20" W along the northerly right-of-way line of Wolfe Street a distance of 82.00 feet to a set iron rod on the easterly right-of-way line of a 16 foot wide platted alley;

thence N 00° 46' 50" E along the easterly right-of-way line of said alley a distance of 63.00 feet to a set iron rod marking the northeast corner of said alley and being situated on the southerly line of said Lot 42;

thence N 88° 45' 20" W along the north line of said alley and southerly line of said Lot 42 a distance of 16.00 feet to a point marking the northwesterly corner of said alley and being situated on the easterly line of a parcel of land currently owned by Michael R. Wilson, et ux, said point being referenced by last mentioned set iron rod;

thence N 00° 46' 50" E along the westerly line of said Lot 42 and the easterly line of said Wilson parcel a distance of 7.00 feet to a point marking the southwest corner of a parcel of land currently owned by Donald L. Matthews;

thence S 88° 45' 20" E along the southerly line of said Matthews parcel a distance of 98.00 feet to a set iron rod, passing a set iron rod for reference a distance of 16.00 feet;

thence S 00° 46' 50" W a distance of 70.00 feet to the **POINT OF BEGINNING**.

Containing in all 0.134 acre of land, more or less, being subject to all legal highways and easements of record.
